## SFNet 2023 40 Under 40 Awards Nomination Instructions

Attach the SFNet 2023 40 Under 40 Awards Nomination Form along with a letter of nomination in Word (250-500 words) explaining why your nominee should be considered for this award and email it to [sfnetawards@sfnet.com](mailto:sfnetawards@sfnet.com). Be sure to include:

- Career achievements
- Leadership skills with examples. Use this definition as a guide: “The ability to create a vision and influence, motivate, inspire and transform others to achieve certain goals towards that vision.”
- Community and/or industry activities (such as charity work, coaching community sports, pro bono work)
- Involvement with SFNet and the secured finance community (articles written, chapter involvement, work on SFNet committees, etc.)

Explain the direct impact your nominee has had on your company and/or the industry **with objective, concrete criteria**. For example, if the candidate is in business development, describe the revenue they have generated, number of deals closed, etc.

In addition to the letter, nominators are strongly encouraged to submit a video (no more than 5 minutes long) with supplemental information. Note that substance is more important than the quality of the video. An iPhone video, for example, is fine.

You **must include** one of the following with the letter of nomination: a) the nominee’s resume, or b) a link to the nominee’s LinkedIn profile. You may also attach optional published articles written by the nominee.
